SUBJECT: SUPPORT OF NEW TOKATA YOUTH CENTER

- WHEREAS:** THE CROW CREEK SIOUX TRIBAL COUNCIL IS THE OFFICIAL AND GOVERNING BODY OF AND FOR THE CROW CREEK SIOUX RESERVATION; AND,
- WHEREAS:** UNDER THE CONSTITUTION AND BY-LAWS OF THE CROW CREEK SIOUX TRIBE, THE TRIBAL COUNCIL IS EMPOWERED AND AUTHORIZED TO ENACT RESOLUTIONS AND ORDINANCES GOVERNING THE MANAGEMENT OF ALL ECONOMIC AND EDUCATIONAL AFFAIRS AND ENTERPRISES OF THE TRIBE; AND,
- WHEREAS:** THE CROW CREEK SIOUX TRIBAL COUNCIL HAS THE AUTHORITY AND RESPONSIBILITY TO OVERSEE ALL TRIBAL MATTERS ON THE CROW CREEK INDIAN RESERVATION; AND,
- WHEREAS:** THE CROW CREEK SIOUX TRIBE SUPPORTS THE EFFORTS OF DIAMOND WILLOW MINISTRIES (DWM) IN OBTAINING FUNDING FOR THEIR NEW PROPOSED "TOKATA YOUTH CENTER;" AND,
- WHEREAS:** THE CROW CREEK SIOUX TRIBE RECOGNIZES THERE IS A GREAT NEED WITHIN OUR HUNKPATI OYATE COMMUNITY FOR ONGOING, STABLE PROGRAMS FOR THE HEALTH, PHYSICAL, EMOTIONAL AND SPIRITUAL DEVELOPMENT OF OUR YOUTH AND FAMILIES; AND,
- WHEREAS:** DIAMOND WILLOW MINISTRIES, A 501c3 NON-PROFIT ORGANIZATION LOCATED ON THE CROW CREEK SIOUX RESERVATION, HAS SERVED THE COMMUNITY, AND IN PARTICULAR THE YOUTH, SINCE INCORPORATION IN 2001; AND,
- WHEREAS:** DIAMOND WILLOW MINISTRIES, AT THE REQUEST OF THE HUNKPATI OYATE COMMUNITY LEADERS AND FAMILIES, DEVELOPED AND BEGAN PROVIDING TOKATA YOUTH CENTER PROGRAMMING IN A TEMPORARY FACILITY IN JANUARY 2015; AND,

NOW THEREFORE BE IT RESOLVED: THAT THE CROW CREEK SIOUX TRIBAL COUNCIL ASSEMBLED IN A BUSINESS SESSION THIS 31ST DAY OF JULY 2017 DOES HEREBY FULLY SUPPORT DIAMOND WILLOW MINISTRIES' CONSTRUCTION OF A NEW AND PERMANENT TOKATA YOUTH CENTER FACILITY AND WE OFFER OUR APPROVAL AND SUPPORT OF THE TOKATA YOUTH CENTER CAPITAL CAMPAIGN FOR THE PURPOSE OF RAISING AND SECURING FUNDS FOR THE CONSTRUCTION OF THIS NEW TOKATA YOUTH CENTER FACILITY.

THIS FOREGOING RESOLUTION WAS DULY ADOPTED BY THE CROW CREEK SIOUX TRIBAL COUNCIL ON THE 31ST DAY OF JULY 2017 IN A BUSINESS SESSION BY A VOTE OF 9 FOR 0 AGAINST 1 ABSENT 0 NOT VOTING FOR THE CROW CREEK SIOUX TRIBE, PURSUANT TO AUTHORITY VESTED IN IT BY ARTICLE VI, SECTION 1 OF THE CONSTITUTION OF THE TRIBE, RATIFIED BY THE TRIBE ON MARCH 11, 1949 AND APPROVED BY THE SECRETARY OF THE INTERIOR ON APRIL 26, 1949 AND WITH AMENDMENTS APPROVED BY THE COMMISSIONER OF INDIAN AFFAIRS ON JUNE 22, 1961, FEBRUARY 25, 1963 AND BY THE AREA DIRECTOR ON JUNE 23, 1980 AND FEBRUARY 4, 1986.
